#### 1. Compensation and Salary Structure

- Basic Salary: Rs. 25,500/-

- House Rent Allowance (HRA): Rs. 2,550/-

- Statutory Deductions: Rs. 200/- will be deducted towards Professional Tax. TDS will be deducted if applicable.
